Blueprint 2030: Innovating and Elevating Oklahoma Higher Education for Tomorrow's Workforce

Priorities include producing workforce ready graduates; stimulating growth in the student pipeline; focusing on student success; an improving system efficiency and effectiveness.

The \$130.4M in new funding for OSRHE was utilized on the following priorities:

- \$29.0M Funding Formula for Institutions
- \$48.9M Faculty Compensation Adjustments
- \$14.0M Financial Aid and Scholarship Programs
- \$1.1M State System Shared Services
- \$16.2M Oklahoma Future Teacher Scholarship and Employment Incentive Program
- \$21.2M State Priority Initiatives and Other Program Adjustments
